NBCA Parent Commitment

This form must be read, signed and returned to the office to enroll your child(ren) in NBCA (one per family).

1. I have read and agree to support the North Bay Christian Academy (hereafter referred to as "NBCA" or "school") Core Values Statement, Philosophy and Statement of Faith as outlined in NBCA Enrollment Inquiry Packet and handbook and recognize that North Bay Christian Academy supports the local Christian churches in the community.
2. I understand the high standards of NBCA in all areas, including character, academics, social and spiritual development. I agree to expect and facilitate completion of homework daily, making sure all books and completed homework are returned to school each day.
3. I have read and understand the Contract of Payment Information and agree to the policies set forth therein, including due dates, penalties, and disenrollment policy.
4. I agree to participate in and support school functions, including fulfilling the required parent service hours and Scrip purchases or pay the substitution fee(s) as outlined in the Payment Contract and Handbook.
5. I recognize that NBCA has the full responsibility and authority for placement of my child (ren) in the proper grade/class.
6. I understand that I am liable for charges arising from the loss or damage to school property (including books issued to my child), regardless of whether such damage was purposeful or accidental.
7. I understand that attendance at NBCA is a privilege and not a right; that the NBCA Board is the determiner of all school policy and thus administratively sets the standard for continued attendance at NBCA.
8. I agree to abide by and fully support the school's disciplinary policy as outlined in the handbook. If, after reasonable effort has been made to discipline my child(ren) and to assist his/her academic adjustment, my child does not comply with the standards of the school, I agree to withdraw my child immediately, and to pay for all costs incurred.
 - a. I recognize that the school reserves the right to dismiss any student who does not respect its standards or cooperate in the education process.
 - b. I hereby authorize the school to use such discipline, as it considers just and necessary for the good of my child, including suspensions. NBCA does not administer corporal punishment.
 - c. I further agree that I will cooperate and discipline my child(ren) in the home when needed to reinforce disciplinary actions taken at school (Proverbs 13:24, 19:18, 22:6, 29:15; Colossians 3:21; and Ephesians 6:4).
9. If any member of my family should experience difficulty arising out of a disagreement with the teacher or other personnel at NBCA, I will not complain to any person. According to Matthew 18, I will register my complaints with the teacher or other personnel first and then with the administration. I agree to follow the "complaint procedure," as outlined in the handbook, for any grievance.
10. I understand that my child(ren)'s likeness may be photographed or videotaped by the school in the course of school activities. I hereby give consent for NBCA to use my child(ren)'s likeness in promotional or advertising materials.
11. I have read, understand, and agree to fully support all policies and procedures outlined in all school admissions materials and to cooperate with teachers, administrators, and the Board. I support the Core Values, mission, curriculum, texts, methods, and discipline of NBCA.
